#### **MEDICAL AESTHETICS PROGRAM**

#### **Brief Program Description**

Education and training of students on information/skills needed to be a Medical Aesthetician.

Laser Hair Removal, Lasers and Light Systems, Photorejuvenation Systems, Microdermabrasion, Microneedling, Hydrafacials, Dermaplaning, Laser Safety, Personal Health, and proper skin care safety and health.

Student will be taught the proper sales techniques: how to connect with people, how to influence them in a positive way and have an understanding of the emotional connection needed between two people to influence the buying and selling to come to fruition.

The first 7 weeks of the program will be online and the last 12 weeks will be all practical, aiming to give our students an experience as you would have while working in a clinic.

Furthermore, we will educate students on how to properly apply for a job. This would include, how to write a resume, how to prepare for a job interview, and things to say/not say during an interview and on your resume.

#### Learning Objectives\*

Upon completion of this program the successful student will have reliably demonstrated the ability to:

#### 1. Laser Hair Removal:

At the end of this program student will be able to demonstrate the knowledge of how to perform laser hair removal. This will include understanding the Fitzpatrick scale, reading hair color and hair type and know how to properly treat clients with the system best suited for them. Understanding when it is safe/not safe to treat someone effectively. Knowing skin conditions and how to assess and treat complications that arise from these treatments. It will include how to set protocols on the systems that are being used for hair removal. They will also have an understanding on what it takes to sell. It's an emotional connection between two people that creates trust and influences them to buy. They will also understand human connection and what it takes to give a client a transformational experience through treatment and customer service.

## 2. Photorejuvenation:

At the end of this program student will be able to demonstrate the knowledge of how to perform Photorejuvenation treatments. This will include understanding the Fitzpatrick scale, knowing how to properly treat clients with the system best suited for them and recommending appropriate products to treat the needs of each individual. Understanding when it is safe/not safe to treat someone effectively. Knowing skin conditions and how to assess and treat complications that arise from these treatments. It will include how to set protocols on the systems that are being used for Photorejuvenation. They will also have an understanding on what it takes to sell. It's an emotional connection between two people that creates trust and influences them to buy. They will also understand human connection and what it takes to give a client a transformational experience through treatment and customer service.

# 3. Exfoliating Treatments and Practical Application of skills:

## a) Microdermabrasion

At the end of this program students will be able to demonstrate the knowledge of how to perform Microdermabrasion treatments, including understanding the correct tips best suited for each individual and recommending appropriate products. The course will include information on understanding when it is safe/not safe to treat someone effectively, knowing skin conditions and how to assess and treat complications that arise from these treatments, as well as how to use a Microdermabrasion system effectively. Students will also have an understanding of the emotional connection between two people that creates trust and influences an individual to buy. Students will understand human connection and what it takes to give a client a transformational experience through treatment and customer service.

#### b) Dermaplaning

Dermaplaning is a physical exfoliation procedure which requires the use of a sterile, surgical scalpel to gently "shave" the skin's surface, removing the top-most layer of dead skin along with fine, vellus hair (aka peach fuzz). Students will learn how to perform a skin analysis on each client, learn how to safely remove the layer of dead skin, vellus hair and any impurities on the surface of the skin, how to assess client's skin and know if this is the right treatment for them. Students will also learn the dos and don'ts of Dermaplaning so your treatments will be completed flawlessly.



#### c) Hydrafacials

HydraFacial treatments use water and serums to exfoliate, extract and hydrate skin. Students will learn how to complete Hydrafacials with the Hydrafacial MD system. HydraFacial MD uses a unique, patented Vortex-Fusion delivery system to exfoliate, extract and hydrate skin, and the spiral design delivers painless extractions. Students will learn how to perform a skin analysis on each client, ensure this is the correct treatment, and receive instruction on treatment and how to make appropriate recommendations on home care based on each client's specific needs.

#### 4. Microneedling

At the end of this program student will be able to demonstrate the knowledge of how to perform Microneedling treatments. This will include understanding the correct depth of needles best suited for them and recommending appropriate products to treat the needs of each individual. Understanding when it is safe/not safe to treat someone effectively. Knowing skin conditions and how to assess and treat complications that arise from these treatments. It will include how to do Microneedling safely and effectively. They will also have an understanding on what it takes to sell. It's an emotional connection between two people that creates trust and influences them to buy. They will have a complete and full understanding of how to do this. They will also understand human connection and what it takes to give a client a transformational experience through treatment and customer service.

#### 5. Consultation, Advanced Sales and How to Prepare for a Job

At the end of this program, they will have an understanding on what it takes to sell. It's an emotional connection between two people that creates trust and influences them to buy. Emotional part of the human brain is what triggers people to buy, and the reasoning part of the brain is where the sale is justified. They will have a complete and full understanding of how to do this. They will also understand human connection and what it takes to give a client a transformational experience through treatment and customer service. They will have confidence in applying for a job. Knowing exactly what to say and do and how to connect to the potential employer. What it takes to have a successful job interview and how to complete a Resume that will give them confidence while applying for these jobs.

#### 6. Laser Safety

At the end of this program the students will have a clear understanding of the dangers of laser systems and how to best protect themselves and their clients from injury.

## 7. Infection Control Practices and Principles

At the end of this module the students will have a clear understanding of what it means to keep their working environment clean and safe while treating their clients. They will learn all the different steps to sanitize properly and will also learn the different kinds of bacteria that can form if their rooms/systems are not properly disinfected. Lastly, they will learn all of the best cleaning products and methods to keep things properly sanitized.

## 8. Anatomy and Physiology

This portion of the program will be teaching our students the Anatomy and Physiology of the entire body. It will be an overview of the parts of the body that aren't necessary to learn to be a Medical Esthetician and a deep dive into the Anatomy and Physiology that is mandatory to know as a Medical Esthetician. In order to have an understanding of certain parts of the human body – it is best to learn it in its entirety so as to be able to put it all together.

### 9. Personal Health

This portion of the program will be giving our students steps to take to ensure they have the knowledge on how to have success in their Personal Health. They will learn some of the basic fundamentals on why exercise is important to stay healthy. They will learn the difference between correct and incorrect ergonomics so they can avoid any injuries while performing their job. They will also learn how to eat healthy, why hydration is so important and tools to be able to learn how to Meditate for a sound mind and body.

## 10. All Things Skin

This module will be teaching students all about the different disorders, pathologies, and skin conditions that they will need to have a full understanding of in order to be successful as a Medical Esthetician

#### Method(s) of Evaluation\*

We will be assessing them through written and practical exams. As well as role-playing with interviews and Consultations. They will be required to perform treatments of which they have learned, and they will also need to complete a consultation and a job interview.

Janiece Wiens and/or one of our Certified Technicians will be supervising every single student to ensure they have a complete and full understanding of each treatment they are doing. They will be applying the skills they have learned in the course on clients as if they were at an actual job.



#### Completion Requirements\*

75% in a minimum of 547 hours required to pass in ALL Written and Oral exams.

## **Program Duration**

- 220 hours Online portion of the program (Duration of the hours would be over 7 weeks) Part A:
- Part B: 388 hours – Practical portion of the program in a Clinical setting (Duration of this would be over 12 weeks)
- Part C: 48 hours - Ongoing training, consulting, coaching. This is to be completed within 6 months from the final day of Part A and B if a student chooses to add this to their program.
